

RELEASE OF LIABILITY, ASSUMPTION OF RISK, & CONTRACT FOR PAYMENT

**READ BEFORE SIGNING - PLEASE MAKE ALL CHECKS PAYABLE TO "SPYB"**

I am paying \$ \_\_\_\_\_ for my legal child/ward, (name of child participating) \_\_\_\_\_ (hereinafter "my child" or "the child") to participate in events and activities of the SOUTH PLYMOUTH YOUTH BASKETBALL (hereinafter the "SPYB") including practice/s, game/s, and team activities, I acknowledge, appreciate, and agree that:

- I am the legal guardian of the child I am signing for herein with full and total authority to sign this document. I sign this document on behalf of myself, my spouse (if any), my child, and any other legal guardian/s (if any) of the child named herein.
- I understand the risk of injury to my child from the activities and events with the SPYB is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist.
- My child is in good health, has no infectious disease/s that can be transferred to another child or coach, and will be able to participate in strenuous physical activity without issue.
- I have been honest about my child's age and placed my child in a group consistent with his/her birthday.
- I understand that playing time, minutes in each game, position, time with coaches, individual instruction, etc., are not guaranteed and may change from game to game and/or practice to practice.
- I KNOWINGLY AND FREELY ASSUME ALL RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES named herein or others, and assume full responsibility for my child's participation in the SPYB.
- I willingly agree to comply with the SPYB stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the SPYB itself, I will remove my child from participation and bring such to the attention of the nearest official immediately.
- I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS SOUTH PLYMOUTH YOUTH BASKETBALL (the "SPYB") and all of its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, owners, coaches, lessors of premises used to conduct the events/games/practices including but not limited to anyone representing the SPYB (hereinafter collectively all of these will be referred to as "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my and/or my child's involvement or participation in the SPYB, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my and/or my child's involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
